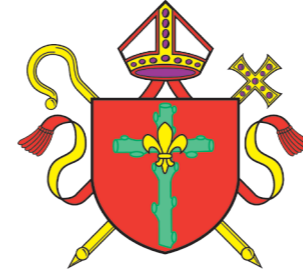

---

### About pledges

1. A pledge is a commitment to pay a certain periodic sum for a specific period of years. Its value to Nottingham Diocese is that it enables us to plan our future income with a high degree of certainty.
2. A Limited Liability Company pays the total (gross) donation to the campaign over a specified number of years. The total annual amount of the pledge can then be set against pre-tax profits when calculating corporation tax liability. Therefore when a Limited Liability Company makes a pledge to a charity, the value of this pledge is much greater than the net cost to the company.
3. For example, if a company paying 23%\* corporation tax makes a donation of £10,000 to the campaign, it can set this against corporation tax. The company saves £2,300 in corporation tax and the net cost of the donation is therefore £7,700 or £160 per month (£1,925 a year)\*\*.
